For what purpose and on what basis we process personal data

Automated decision making

Guido Winkler VA does not make any decision based on automated processing on matters that can have consequences for people.

How long we keep personal data

Guido Winkler VA does not store your personal data longer than is strictly necessary to realize the goals for which your data is collected. We use the following retention periods for the following (categories) of personal data:

Name > to request deregistration or disuse > for communication

E-mail > to request deregistration or disuse > for communication

Address > only with active consent and necessity + the above > for communication

Phone > only with active consent and necessity + the above > for communication

Additional data > only with active consent and necessity + the above > for communication and transactions

Sharing personal data with third parties

Guido Winkler VA does not sell your data to third parties and only provides it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. We conclude a processor agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. Guido Winkler VA remains responsible for these processing operations.

Cookies, or comparable techniques, that we use

Guido Winkler VA uses functional and analytical cookies. A cookie is a small text file that is stored in the browser

of your computer, tablet or smartphone when you first visit this website. Guido Winkler VA uses cookies with a purely technical functionality. These ensure that the website works properly. We do not track your surfing behavior individually. Sitewit analyzes data and reports anonymously. It distinguishes between old and new users, the number of users, the time on the website and the number of page views.

On your first visit to our website, we have already informed you about these cookies and asked for permission to place them. It has also been explained how you can remove it. Please note that the services on this website are obtained from companies located in the United States.

You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously saved via the settings of your browser. For an explanation, check the link in our cookie consent.

Technical cookies are placed on this website by third parties. These are Yola, Synthasite (also Yola) and Sitewit for function and analysis. Most cookies (5) are placed for the duration of your session (Sitewit). The cookie (1) that distinguishes old and new users for a period of 1 year. Other cookies are stored for a maximum period of 30 days.

View, adjust or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Guido Winkler VA and you have the right to data portability. This means that you can submit a request to us to send the personal data that we hold about you in a computer file to you or another organization mentioned by you.
